MERGER OF PARCELS FILING PROCEDURE BY CERTIFICATE OF COMPLIANCE

- 1. The owner or owner's representative shall submit an application and filing fee in an amount determined by the City Engineer to the Community Development Department.
- 2. The City Engineer or an authorized representative may approve, conditionally approve or deny the Certificate of Compliance.
- 3. Upon approval, a "Notice of Merger" shall be filed with the County Recorder. The form and content of the notice shall be as required by the City Engineer.
- 4. In approving such merger, the City may impose reasonable conditions.
- 5. Any applicant dissatisfied with any requirement, ruling, finding, or disapproval by the City Engineer with respect to the adjustment, he or she shall within ten (10) days after such action, appeal in writing to the City Council for relief. Written appeal shall be filed with the City Clerk and set forth the grounds and reasons for such an appeal. City Council may sustain, modify, or overrule any such ruling, finding, or disapproval of the City Engineer. City Council shall approve the lot line adjustment pursuant to its affirmative determination of finding delineated in Section 9.84.020. The decision of the City Council is final.

FINDINGS

The applicant for a Certificate of Compliance for a Merger of Parcels shall substantiate to the satisfaction of the City of Bell Gardens, the following facts:

- a) That all owners of an interest in the real property have consented to the merger; and
- b) That the proposed merger complies with all applicable requirements for the merger of land as provided by the Subdivision Map Act and the City of Bell Gardens' Subdivision Ordinance.

Government Code Section 66499.20 ¾ provides that a local agency may authorize the merger of contiguous parcels under common ownership without reverting to acreage. The proposed merger is subject to review and approval by the local agency and becomes effective when a Notice of Merger (Certificate of Compliance) is recorded with the County Recorder.

(See Certificate of Compliance). A letter must be issued indicating that the bank has no objections to the requested lot merger.
