1. GENERAL MOTION TO WAIVE FULL READING AND APPROVE ORDINANCES BY TITLE ONLY PURSUANT TO CALIFORNIA GOVERNMENT CODE SECTION 36934

In order to expedite the conduct of business at City Council meetings, California State Law (California Government Code Section 36934) allows Ordinances to be read by title if a majority of the legislative body supports the motion to waive the full reading.

Recommendation:

It is staff recommendation that the City Council approve a general motion to waive full reading and approve Ordinances by title only pursuant to California Government Code Section 36934.

Recommendation:

3. WARRANT REGISTERS AND WIRE TRANSFERS

In approving the action of receiving and filing the warrant registers, the official minutes of the Bell Gardens City Council should state that each individual member of the City Council is not voting on, influencing the outcome of, or participating in approving, accepting, receiving or filing any warrant which bears the name of the same council member, or pays for any costs or expenses, or otherwise benefits the same named council member. Each council member will not be participating, influencing or voting on any such warrant bearing their name or which benefits the same named council member, but with that exception is voting in favor of receiving and filing all other warrants contained in this report, unless otherwise noted on the record at the time of the approval of the action required by this report.

Recommendation:

4. <u>UPDATE TO THE CITY OF BELL GARDENS RECORDS RETENTION SCHEDULE</u>

Update to the City of Bell Gardens 2009 Record Retention Schedule.

Recommendation:

It is staff recommendation that the City Council, by motion, adopt the attached resolution, updating the City's Record Retention Schedule authorizing the disposition of certain City records, and rescinding Resolution No. 2009-03.

5. PURCHASE OF TRAINING AMMUNITION FROM DOOLEY ENTERPRISES

The Police Department has a need to purchase ammunition at quarterly intervals throughout the fiscal year for training purposes. An open purchase order is needed to facilitate acquisition of the ammunition when required.

Recommendation:

It is staff recommendation that the City Council adopt the attached Resolution, approving a purchase order to Dooley Enterprises, Inc. for the acquisition of ammunition.

6. <u>APPROVAL OF PLANS AND SPECIFICATIONS AND AUTHORIZATION TO SOLICIT BIDS FOR THE SLURRY SEAL, ZONE 1 IMPROVEMENT PROJECT- C.I.P. NO. 3872</u>

Staff initiated a slurry seal program to extend the pavement life span of City streets, and divided the City into 5 maintenance/slurry zones. Staff is recommending commencement of Slurry Seal Zone 1. Engineering staff has completed the design and construction documents for the project. Upon authorization from City Council, staff will proceed with the bid phase of the project.

Recommendation:

It is staff recommendation that the City Council by motion:

- 1. Approve the plans and specifications for the Slurry Seal, Zone 1, Improvement Project; and
- 2. Authorize staff to solicit bids for the construction of this project.

7. APPROVAL OF AGREEMENT FOR LEGAL SERVICES WITH INTERIM CITY ATTORNEY FIRM OLIVAREZ MADRUGA LEMIEUX O'NIELL, LLP

The law firm of Olivarez Madruga Lemieux O'Neill, LLP is the City's current Interim City Attorney. It is necessary for the Council to approve an Interim City Attorney agreement to continue with this firm at this time.

Recommendation:

It is staff recommendation that the City Council by motion approve an Interim City Attorney agreement in a form to be approved by the Acting City Manager.

8. POLICE DEPARTMENT TO UPGRADE NEW CAD/RMS SERVER PROJECT

The Police Department has a need to upgrade its original server project quote to maintain state of the art communication and up-time with our new CAD/RMS project.

Recommendation:

It is staff recommendation that the City Council adopt the attached Resolution, approving a purchase order to Lan Wan Enterprises, Inc. for the acquisition of two network servers for the PD's upcoming CAD/RMS project.

9. RESOLUTION AWARDING CONTRACT FOR ENVIRONMENTAL COMPLIANCE SERVICES FOR PROP 1 GRANT - FORD PARK INFILTRATION CISTERN PROJECT

To meet the requirements to divert and treat urban runoff imposed the LA-RWQCB Stormwater Permit the City of Bell Gardens in cooperation with other cities submitted the Proposition 1 (Prop 1) implementation grant application for the planning, design, and construction of the John Anson Ford Park Infiltration Cistern Project. Staff prepared a request for proposal for environmental consultant services, received 3 proposals and is recommending that Rincon Consultants Inc. be considered for award of a three-year contract for environmental consultant services for this project.

Recommendation:

It is staff recommendation that the City Council by motion: adopt the attached Resolution awarding a three (3) year contract to Rincon Consultants, Inc. for environmental consulting services for the Prop 1 – Ford Park Infiltration Cistern Project.

10. ACCEPTANCE OF CONSTRUCTION CONTRACT FOR THE CITYWIDE SAFETY ENHANCEMENTS PROJECT—C.I.P. NO. 3835

The City of Bell Gardens was awarded a total of \$802,000 for the construction of pedestrian and bicycle safety improvements at various locations within the city. Horizon Construction Company International, Inc. finalized construction on August 15, 2018. The project inspector conducted their final inspection, reviewed the project documents and determined that the project was completed satisfactorily. Staff is recommending that the City Council accept the project as complete and authorize staff to file the Notice of Completion.

Recommendation:

It is staff recommendation that the City Council by motion:

- 1. Accept the construction contract for the Citywide Safety Enhancements Project; and
- 2. Authorize staff to file the Notice of Completion.
