Re: Organics Recycling Requirements for Businesses and Multi-Family Communities, State

Regulation AB 1826

Dear City of Bell Gardens Business Owner or Manager:

Assembly Bill AB 1826, the Mandatory Organics Recycling Regulation, was signed by Governor Brown in 2016, and phases in requirements for commercial businesses and multi-family complexes to divert organic materials from landfilling. Organic material is defined in the bill as food waste, food-soiled paper, landscaping waste and compostable utensils.

Implementation began with the largest food waste generators, such as grocery stores, large restaurants, and food processing businesses. As of January 1, 2019 the legislation now requires businesses and multi-family complexes that generate 4 or more cubic yards of trash a week to comply with the regulations. However, multi-family complexes are only required to recycle landscaping waste which can be managed by your property's landscaper if the landscape materials are taken offsite and diverted from landfilling.

Mandatory Organics Recycling Implementation Schedule

Description	Implementation Date
Tier 1: Businesses with 8 cubic yards of organic waste per week	April 1, 2016
Tier 2: Businesses with 4 cubic yards of organic waste per week	January 1, 2017
Tier 3: Businesses with 4 cubic yards of trash per week	January 1, 2019
Tier 4: Businesses that generate 2 cubic yards or more of trash per week*	January 1, 2020

^{*}Tier 4 businesses will only be required to recycle organics in the event that the State has not reached its goal to reduce landfilled organics by 50%.

How to Arrange for Organics Services

- Businesses and multi-family complexes that meet the threshold requirements of AB 1826 must arrange for organic waste recycling services. Please contact your current solid waste and recycling hauler to find out how they can help you recycle your organic waste or report any current onsite organics recycling programs.
- Businesses and multi-family complexes may also donate or make other arrangements to divert
 organics from landfilling. Some of these methods include self-hauling the materials to organics
 recycling facilities, or donating edible food. Your business may receive tax deductions and create
 stronger ties with your community by donating food to charitable organizations. Be sure to inform
 your waste hauler of any organics or landscape waste recycling programs your property currently
 uses to recycle or divert organics (donations, composting, self-haul, etc.).

Annual Site Visits

AB 1826 requires that businesses and multi-family complexes meeting the thresholds of the regulation that do not have an organics recycling program are visited annually. These visits will be performed by your waste hauler to inform your business of the regulations, offer organics recycling solutions, and document all current organics recycling programs in place.

Opportunities to Save Resources and Help the Environment

Organics represent approximately 35% of all material currently landfilled. Recycling organic materials conserves resources and reduces greenhouse gas emissions. It extends the life of our landfills and helps create a healthy environment for our community and future generations.

Be Sure to Educate Your Employees and Tenants

Employees and tenants are key to a successful organics recycling program. Please make sure your employees and tenants know which organic materials can be recycled as organics and where to place the materials for temporary storage and ultimate collection or donation.
