STOP SIGN WARRANT

STUDIES 5 INTERSECTIONS:

representing Roldan, Associate Engineer Mr. Infrastructure Engineers, gave the report. The City received a formal request to conduct a traffic analysis investigation for installing stop signs at 5 intersections. Residents expressed their concerns regarding speeding, accidents, near misses, poor visibility and overall lack of pedestrian safety at these intersections. Observations were performed in March 2019 and the engineering analysis was conducted in April 2019 and these are the

1) Foster Bridge Blvd and Kress Ave/Charner findings: St Intersection - The stop sign warrant analysis indicates that the MUTCD warrants for collisions and traffic volumes are not satisfied and neither is the removal of needed on-street parking. The installation of all way stops is not recommended. 2) Foster Bridge Blvd and Suva St Intersection - Same thing, the analysis indicated that the MUTCD warrants were not satisfied and neither the removal of on-street parking, so no installation of all-way stops is recommended. Loveland St and Granger Ave Intersection - It is recommended to install stop signs on Loveland both Granger Avenue westbound at eastbound and This will create an all-way stop approaches. intersection and can be supplemented with the appropriate striping and pavement legends to mitigate future broadside collisions. 4) Florence PI and Granger Ave Intersection - Again the warrants were not satisfied for collisions nor traffic volumes and removal of needed on-street parking is not recommended, no all-way stops 5) Suva St and Loveland Street is recommended. Intersection - Again this intersection does not meet the warrants for MUTCD and removal of residential on-street parking is not recommended. No stop signs installation is recommended.

Four out of the five intersections, is a receive and file. The installation of stop signs on Loveland Street at Granger Avenue is recommended and will create an all-way stop intersection and should be supplemented with appropriate signage and legend markings to mitigate future broadside collisions.

The fiscal impact is approximately \$850 and is available in the Street Maintenance Budget this year.

Commissioner Heredia mentioned that Loveland St and Suva St is very close to a school. Is there signage that at least indicates that for motorists. Ms. Vu clarified that there are 'school zone signs' in the proximity of every school. Mr. Roldan added that it is a state requirement to have these signs up.

Commissioner Galvan made the motion and Commissioner Heredia second the motion.

# TRAFFIC CALMING STUDY CHALET DRIVE:

Chau Vu gave the report. The City received a petition for traffic calming measures along Chalet Drive between Gage Ave and Foster Bridge Blvd. Residents are concerned with vehicular speeding and traffic safety. The traffic engineer documented vehicular speeding along the segment. A total of 18 traffic collisions have been reported within the past 3 years. Mid-block collisions were the results of vehicles not abiding to the

right-of-way laws, improper turns and unsafe speeds. To improve traffic safety and reduce speeding the Education following categories are necessary. Community outreach is necessary. Engineering -Additional cost-effective methods are striping edge lines to define curb side parking will have the driver perceive narrower roadways thereby reducing their speeds. Other alternatives are speed humps, speed cushions but they also delay emergency response vehicles. such as "Speed Enforced by Radar' could also help. And Enforcement - Police enforcement, police presence can help. Based on the engineering analysis it is recommended that the Commission authorize staff to meet with the community surrounding Chalet Drive to discuss alternatives and option since these will affect them and these things are permanent. Staff will them communicate their finds and come back to the Commission.
