## **RESOLUTION NO. 2021-10**

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF BELL GARDENS, CALIFORNIA, UPDATING THE HOURLY PAY SCHEDULE FOR CERTAIN POSITIONS DESIGNATED AS TEMPORARY/PART-TIME PURSUANT TO THE INCREASE IN THE STATE OF CALIFORNIA'S MINUMUM WAGE FOR 2021 THROUGH 2022

WHEREAS, there is a need to address part-time pay ranges pursuant to the 2021 scheduled California minimum wage increase to \$14.00 per hour and 2022 scheduled California minimum wage increase to \$15.00 per hour; and

WHEREAS, certain classifications are compensated at a pay rate that is currently less than the scheduled State of California minimum wage increases.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Bell Gardens as follows:

<u>SECTION 1.</u> The City Council, hereby finds and determines that the foregoing recitals are true and correct, constitute a material part of this resolution, and therefore incorporate them herein in their entirety as part of the findings.

<u>SECTION 2.</u> Certain part-time positions with the City service are compensated on an hourly basis in the interest of efficient administration of City government and to serve the public welfare. The following hourly positions and salary ranges are authorized:
