URGENCY ORDINANCE NO. 922-U

AN URGENCY ORDINANCE OF THE CITY OF BELL GARDENS, CALIFORNIA, ESTABLISHING AN INTERIM FREEZE ON RENT INCREASES FOR 45-DAYS WITH THE ABILITY TO EXTEND THE ORDINANCE

NOTICE IS HEREBY GIVEN that the City Council of the City of Bell Gardens will consider the adoption of Urgency Ordinance No. 922-U.

WHEN: Monday, April 25, 2022, at 6:00 p.m.

WHAT: This interim urgency ordinance is intended for the immediate preservation of the public peace, health, and safety, and temporarily imposes a moratorium that prohibits rent increases for certain residential units for a 45-day period with the ability to extend further.

If approved, this ordinance will take effect and be in force immediately upon its adoption and will expire 45-days from April 25, 2022, unless extended or replaced by the Bell Gardens City Council with a permanent Residential Rent Regulation Ordinance.

WHERE: This item will be discussed at the regular City Council meeting of the City of Bell Gardens in Bell Gardens City Hall in the Council Chambers via teleconferencing.
