AN URGENCY ORDINANCE AMENDING URGENCY ORDINANCE NO. 924-U TO EXTEND THE TEMPORARY PROHIBITION ON RENT INCREASES FOR CERTAIN RESIDENTIAL PROPERTIES TO THE DATE THE PROPOSED ORDINANCE NO. 925 THAT WOULD ESTABLISH PERMANENT RENT STABILIZATION AND TENANT EVICTION PROTECTIONS

**NOTICE IS HEREBY GIVEN** that the City Council of the City of Bell Gardens will conduct a public hearing to consider an urgency ordinance amending Ordinance No. 924-U to avoid a lapse in protections. If approved, the urgency ordinance would extend the temporary prohibition on rent increases from the current expiration date of October 9, 2022, to October 12, 2022. Proposed Ordinance 925 would establish permanent rent stabilization and tenant eviction protection regulations in the City of Bell Gardens. The urgency ordinance shall expire by its own terms upon Ordinance 925 taking effect.
