NOTICE OF PUBLIC HEARING

CONSIDERATION OF A RESOLUTION APPROVING PROJECTS FOR THE 49TH PROGRAM YEAR (FY 2023-2024) COMMUNITY DEVELOPMENT BLOCK GRANT (CDBG) PROGRAM; AND ADOPTION OF A RESOLUTION APPROVING THE CDBG BUDGET FOR THE 49TH YEAR PROGRAM (FY 2023-2024) FOR THE CITY OF BELL GARDENS

NOTICE IS HEREBY GIVEN that pursuant to the Housing and Community Development Act of 1974, 12 U.S.C. 1706e, (the Act) for the development of viable urban communities, the City Council of the City of Bell Gardens will conduct a public hearing to consider comments and suggestions from the community for the utilization of CDBG funds and adoption of a resolution allocating 2023-2024 Program Year funds for capital project costs for the Project known as the John Anson Ford Park Aquatics Center within the City of Bell Gardens and approving the FY 2023-2024 49th Year CDBG Budget.

ENVIRONMENTAL DETERMINATIONS: City Council adoption of this resolution is not subject to the California Environmental Quality Act (CEQA) pursuant to Section 15323 of the state's CEQA Statutes and Guidelines, since there is a reasonable expectation that the future occurrence of the normal operations of facilities for public gatherings represents no change in the operation of the facility.

INVITATION TO BE HEARD/PUBLIC PARTICIPATION: The public hearing will be held before the City of Bell Gardens City Council on Monday, December 12, 2022, at 6:00 p.m. Pursuant to AB 361, please be advised that members of the Bell Gardens City Council may participate in meetings telephonically. The public may attend the meeting in person or may view the meeting online. The meeting will be recorded and live streamed on the City's website at https://www.bellgardens.org/i-want-to/watch-city-council-meetings. Public comments are limited to three (3) minutes per person. Members of the public can access and participate in the meetings as follows:

IN-PERSON: Members of the public can provide in-person comments at the podium in the Council Chamber. The Council Chamber will have seating available for members of the public to attend the meeting in-person. For your safety, space is currently limited to 50 members of the public. Masking is required for all in attendance. Public comments are limited to three (3) minutes per speaker, unless a different time is announced by the presiding chair. Speakers who wish to address the Council should do so by submitting a

"Public Comment Card" card by 5:00 p.m. for Closed Session items and by 6:00 p.m. for all other designated public comment periods as listed.
