## NOTICE OF PUBLIC HEARING



### **SITE PLAN REVIEW NO. 2023-036 TO AUTHORIZE OUTDOOR AUTOMOBILE STORAGE AT 7629 PERRY ROAD**

**NOTICE IS HEREBY GIVEN**, the Planning Commission of the City of Bell Gardens will conduct a public hearing to consider adoption of a resolution approving Site Plan Review No. 2023-036 to authorize the establishment of outdoor automobile storage on a vacant lot 5,920 square feet in size located at 7629 Perry Road, Bell Gardens, CA 90201. The subject site is zoned M-1-PBD (Light Industrial – Parking and Buffer District) with the General Plan Land Use Designation “Industrial.” The subject site is identified as the County of Los Angeles Assessor’s Parcel Number 6228-015-027.

**DATE OF HEARING:** Wednesday, July 19, 2023

**TIME OF HEARING:** 6:00 P.M., or as soon thereafter as possible.

**ENVIRONMENTAL DETERMINATION:** The proposed project is categorically exempt from the California Environmental Quality Act (“CEQA”) pursuant to CEQA Guidelines, Section 15332, Class 32 (In-Fill Development).
