A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF BELL GARDENS, CALIFORNIA ADOPTING THE HOURLY PAY SCHEDULE FOR POSITIONS DESIGNATED AS TEMPORARY/PART-TIME

WHEREAS, temporary / part-time positions are essential to the City's operations and public service delivery; and

WHEREAS, there is a need to address temporary / part-time hourly pay ranges pursuant to State requirements, industry standards and market competitiveness; and

WHEREAS, this resolution sets forth the hourly pay schedule for positions designated as temporary / part-time.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Bell Gardens as follows:

SECTION 1. The City Council finds that the above recitals are true and correct and incorporate them herein.

<u>SECTION 2.</u> Certain part-time positions with the City service are compensated on an hourly basis in the interest of efficient administration of City government and to serve the public welfare. The following hourly positions and salary ranges are authorized effective the first full pay period following ratification:

SECTION 3. In order to recruit Police Officers during their attendance at the Police Academy to fill vacant Police Officer positions, a Police Trainee position is authorized.

SALARY AUTHORIZED (PTRN) \$3,617 per month

The number of positions authorized by this resolution is the number of vacancies then existing or pending as determined by the Personnel Officer.

SECTION 4. The City Clerk shall attest and certify to the passages and adoption of this Resolution and enter it into the book of original resolutions, and it shall become effective immediately upon its approval.
