NOTICE OF PUBLIC HEARING

A RESOLUTION OF THE PLANNING COMMISSION OF THE CITY OF BELL GARDENS APPROVING TENTATIVE PARCEL MAP NO. 84125, VARIANCE NO. 2023-017 AND CONDITIONAL USE PERMIT NO. 2023-017 TO AUTHORIZE THE DEVELOPMENT OF A THREE (3)-UNIT RESIDENTIAL CONDOMINIUM PROJECT

NOTICE IS HEREBY GIVEN, the Planning Commission of the City of Bell Gardens will conduct a public hearing to consider adoption of a resolution approving Tentative Parcel Map No. 84125 to create one (1) parcel for condominium purposes from an existing lot 11,420 square feet, Variance No. 2023-017 to authorize a reduction in common open space area, Conditional Use Permit No. 2023-017 to authorize the development of a three (3)-unit residential condominium project.

DATE OF HEARING: Wednesday, September 20, 2023

TIME OF HEARING: 5:15 P.M., or as soon thereafter as possible.

ENVIRONMENTAL DETERMINATIONS: In accordance with the California Environmental Quality Act ("CEQA") Guidelines, Tentative Parcel Map No. 84125, Variance No. 2023-017, and Conditional Use Permit No. 2023-017 are categorically exempt pursuant to Section 15315, Class 15 (Minor Land Divisions), Section 15332, Class 32I (In-Fill Development), and Section 15303(b), Class 3 (New Construction or Conversion of Small Structures).

INVITATION TO BE HEARD/PUBLIC PARTICIPATION: The public hearing will be held before the City of Bell Gardens Planning Commission on Wednesday, September 20, 2023, at 5:15 p.m. The public may attend the meeting in person or may view the meeting online. The meeting will be recorded and live streamed on the City's website at <https://www.bellgardens.org/i-want-to/watch-citycommission-meetings>. Public comments for the public hearing are limited to three (3) minutes per person. Members of the public can access and participate in the meetings as follows:

The Council Chamber will have seating available for members of the public to attend the meeting in-person, subject to capacity limits. Public comments for the public hearing are limited to three (3) minutes per speaker.
