NOTICE OF PUBLIC HEARING

A RESOLUTION OF THE PLANNING COMMISSION OF THE CITY OF BELL GARDENS APPROVING CONDITIONAL USE PERMIT NO. 2023-030 TO AUTHORIZE A TYPE 41 DEPARTMENT OF ALCOHOLIC BEVERAGE CONTROL LICENSE FOR ON-SALE BEER AND WINE ALCOHOL BEVERAGE SALES AT ROLL-EM-UP TAQUITOS RESTAURANT

NOTICE IS HEREBY GIVEN, the Planning Commission of the City of Bell Gardens will conduct a public hearing to consider adoption of a resolution approving a conditional use permit to authorize issuance of a Type 41 (on-sale beer and wine) Department of Alcoholic Beverage Control ("ABC") license to Roll-Em-Up Taquitos for alcohol beverage sales at 7220 Eastern Avenue, Unit F located within Zone C-4 (Heavy Commercial) and within the RC (Regional Commercial) General Plan Land Use Designation.

DATE OF HEARING: Wednesday, October 18, 2023

TIME OF HEARING: 5:15 P.M., or as soon thereafter as possible.

ENVIRONMENTAL DETERMINATIONS: Staff recommends that proposed conditional use permit be found exempt from the California Environmental Quality Act ("CEQA") pursuant to CEQA Guidelines, Section 15301, Class 1: Existing Facilities.

INVITATION TO BE HEARD/PUBLIC PARTICIPATION: The public hearing will be held before the City of Bell Gardens Planning Commission on Wednesday, October 18, 2023, at 5:15 p.m. The public may attend the meeting in person or may view the meeting online.
