2. <u>SUCCESSOR AGENCY APPROVAL OF THE RECOGNIZED OBLIGATION PAYMENTS SCHEDULE 17-18 AND THE JULY 1, 2017 – JUNE 30, 2018 ADMINISTRATIVE BUDGET</u>

The redevelopment dissolution laws (AB 1x 26, et.al) established a comprehensive statutory process for the dissolution and wind down of all redevelopment agencies.

Pursuant to Health and Safety Code 34177, each Successor Agency was required to submit a ROPS to the California Department of Finance (DOF) every six months. On September 22, 2015, the Governor signed SB 107 which revised the timeline for the preparation of the ROPS from a bi-annual process to an annual process for the fiscal period beginning July 1, 2016. Pursuant to AB 1x 26, et.al, two matters are being presented to the SA Board for consideration of approval: 1) ROPS 17-18; and 2) Administrative Budget for July 1, 2017 through June 30, 2018.

Recommendation: It is recommended that the Successor Agency (SA) adopt Resolution No. SA 2017-01 approving:

- A. Draft Recognized Obligations Payment Schedule 17-18 (ROPS 17-18) which details the obligations of the Successor Agency for the period July 1, 2017 through June 30, 2018; and
- B. Proposed Administrative Budget for July 1, 2017 through June 30, 2018;

In approving the action of receiving and filing the warrant registers, the official minutes of the Bell Gardens City Council should state that each individual member of the City Council is not voting on, influencing the outcome of, or participating in approving, accepting, receiving, or filing any warrant which bears the name of the same Council member, or pays for any costs or expenses, or otherwise benefits the same named Council member. 4. PURCHASE OF MOBILE COMPUTERS

In 2015, via Resolution, City Council approved the purchase of a 'Getac F110 Rugged Tablet' to outfit new Ford Explorer police vehicles designated for patrol. The existing mobile devices from L3 Communications had reached their useful life and were no longer under warranty. The operational goal has been to replace all field units with the new tablet for consistency purposes as we phase out the current mobile computing platform, given the new tablet's speed and multitasking ability in relation to our communications software. Phase I of this project is to replace the mobile devices in each of the three vehicles operated by the Community Service Officers who handle parking enforcement and field assists of patrol units. To maintain consistency of existing new technology, the Getac F110 Tablet is the preferred hardware to replace existing equipment. The police department has an existing relationship with DuraTech USA for the purchase of this equipment. Duratech USA custom built our existing tablets to our specifications and facilitated installation with an authorized vendor, Black and White Emergency Vehicles, Inc. Duratech USA will provide the same custom tablet to create consistency of our equipment. Duratech USA is the only known vendor who provides the service of a custom built Getac F110 rugged tablet and coordinated installation.

Recommendation: It is staff's recommendation that the City Council Adopt Resolution No. 2017-04 entitled, "A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF BELL GARDENS AUTHORIZING THE PURCHASE OF MOBILE COMPUTING HARDWARE FROM DURATECH USA, INC. FOR USE BY THE POLICE DEPARTMENT."

5. <u>APPROVING AMENDMENTS TO EXISTING AGREEMENT BETWEEN THE CITY OF BELL GARDENS AND GOLFLINKS</u>

On January 1, 2016 GolfLinks took over the entire golf operations at Bell Gardens Golf Course, including being responsible for the maintenance of same. GolfLinks invested a significant amount of time repairing the infrastructure of the clubhouse. The noticeable improvements will be a positive factor for golf patrons for years to come. Financially, the course has not fared as well as anticipated-even after the changes to the clubhouse. After careful analysis, the City of Bell Gardens has decided to utilize the same management model as before the current operations agreement with GolfLinks, where the City of Bell Gardens manages and operates the Golf course, possibly including the concession operations, and the maintenance of the golf course is out-sourced to a third-party contractor. The City of Bell Gardens asked GolfLinks to submit a price for only Golf Course maintenance. Attached in Exhibit "B" are the proposed maintenance guidelines.

Recommendation: It is staff's recommendation that the City Council adopt Resolution No. 2017-05, approving the amendments to the existing agreement by and between the City of Bell Gardens and GolfLinks.

6. <u>CITY COUNCIL APPOINTMENTS TO EXTERNAL COMMITTEES</u>

The City of Bell Gardens resides within a larger geo-political environment with a variety of complex issues and concerns. Council Members are typically appointed as representatives on various external boards, commissions, and committees who serve the larger geo-political region. The Council typically makes revisions to the list yearly following the annual Council reorganization.

Recommendation: It is staff's recommendation that the City Council make changes, reappointments, or appointments as necessary to the attached, revised matrix of Council Appointments to External Regulatory and Advisory Boards, Commissions, and Committees.

7. ADOPT RESOLUTION NO. 2017-06 (1) APPROVING THE FINANCIAL ASSISTANCE APPLICATION FOR A FINANCING AGREEMENT FROM THE STATE WATER RESOURCES CONTROL BOARD FOR THE PLANNING AND DESIGN OF UPGRADING WELL PUMP AND INSTALLATION OF A NEW 2.0 MG (MILLION-GALLON) RESERVOIR WITH PUMP STATION, AND (2) AUTHORIZING THE CITY MANAGER TO SUBMIT SAID APPLICATION FOR THIS PURPOSE

On February 8, 2016, the City Council entered into a Memorandum of Understanding (MOU) with the Water Replenishment District of Southern California (WRD) to participate in the Safe Drinking Water for Disadvantaged Communities Pilot Program. Under the MOU, WRD is eligible to be reimbursed for its costs to prepare the application, which includes the technical consultants as well as environmental consultants only if the City of Bell Gardens is successful in obtaining funding from the State Board. The WRD has been successful in working with 6 other cities as part of this Safe Drinking Water for Disadvantaged Communities Pilot Program. Under the MOU, WRD would supply technical consultants, including an engineering firm, and a firm which specializes in funding for disadvantaged communities to draft and submit the application. The application is now ready to be submitted and requires a resolution authorizing the City Manager to submit the financial assistance application to the State Water Resources Control Board for the planning and design of upgrading the well pump and installing a new 2.0 million-gallon reservoir with pump station.

Recommendation: It is staff's recommendation that the City Council Adopt Resolution No. 2017-06 (1) approving the financial assistance application for a financing agreement from the State Water Resources Control Board for the planning and design of a new 2 million-gallon reservoir and pump station, and (2) authorizing the City Manager to submit said financial assistance application for this purpose.

8. GREENWOOD AVENUE PARKING RESTRICTIONS RESOLUTION NO. 2017-07

Recently the City of Commerce reached out to the City of Bell Gardens to discuss the city boundary for the east side of Greenwood Avenue. It was recently brought into question when Sheriffs investigated a parking enforcement complaint on Greenwood Avenue. Bell Gardens engineers have researched various tract maps and parcel maps; and have confirmed that both the west and east side of Greenwood Avenue belongs to the City of Bell Gardens. Residents along Greenwood Avenue still belong to the City of Commerce and their services remain the same. The only difference now is that the City of Bell Gardens is responsible for street maintenance and parking enforcement along the east side of Greenwood Avenue, which includes both the sidewalk and parkway.

Recommendation: It is staff's recommendation that the City Council by motion:

Adopt Resolution No. 2017-07 authorizing parking restrictions to the eastside of Greenwood Avenue for street sweeping purposes in the City of Bell Gardens, and authorize staff to install the corresponding signage for notice and enforcement purposes, consistent with the Bell Gardens Municipal Code.
