### **NOTICE OF PUBLIC HEARING**

## SITE PLAN REVIEW NO. 2023-036 TO AUTHORIZE AUTOMOTIVE REPAIR FACILITIES OUTDOOR AUTOMOBILE STORAGE

NOTICE IS HEREBY GIVEN, the Planning Commission of the City of Bell Gardens will conduct a public hearing to consider adoption of a resolution approving Site Plan Review No. 2023-036 to authorize the establishment of an offsite primary use of outdoor storage of vehicles where no repair is done on a vacant lot 5,920 square feet in size within Zone M-1-PBD (Light Industrial – Parking and Buffer District) with the I (Industrial) General Plan Land Use Designation located at 7629 Perry Road, Bell Gardens, CA 90201.

DATE OF HEARING: Wednesday, November 15, 2023

**TIME OF HEARING:** 5:15 P.M., or as soon thereafter as possible.

**ENVIRONMENTAL DETERMINATIONS:** Staff recommends that the proposed project be found categorically exempt from the California Environmental Quality Act (CEQA) pursuant to CEQA Guidelines, Section 15332, Class 32 (In-Fill Development).


