# 4. REQUEST FOR CITY COUNCIL APPROVAL FOR TRANSFER OF POINTS/INTEREST IN THE BICYCLE CASINO

Pursuant to *Bell Gardens Municipal Code Section No. 5-25*, the Bicycle Casino has requested that the City Council approve the transactions and transfers. The transactions and transfers have been reviewed by the State of California Gambling Control Commission and found to be lawful at this time.

**Recommendation:** It is staff's recommendation that the City Council approve the transfer of interest between existing partners and adopt Resolution No. 2017-09, "A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF BELL GARDENS APPROVING THE SALES AND TRANSFER OF POINT HOLDER INTEREST."

#### 5. WILLIAMS SCOTSMAN TEMPORARY TRAILER LEASE AGREEMENT

The Recreation and Community Services Department's office area at Ford Park was significantly damaged by water during this season's heavy rains. The severe weather has accelerated the deterioration of the sixty (60) year old building's roof, along with interior damage to the carpet, ceiling and walls. This facility will be in need of significant remediation, repair and replacement of internal infrastructure once the roof is repaired. Because of the current water damage, the area is not inhabitable. A temporary office needs to be set-up while construction takes place in order to house staff and continue to provide the community service needs of our residents.

**Recommendation:** It is staff's recommendation that the City Council adopt Resolution 2017-10 authorizing the following:

- (1) Approves and authorizes the City Manager to enter into an agreement with Williams Scotsman, for the 1 year lease of a temporary trailer to house the public counter at Ford Park and Sports staff while the roof and other water related damages are repaired to the facility for the total amount of \$23,252.81; and
- (2) Authorize the appropriation of \$12,510.14 from the City's General Fund to the FY 2016-2017 Budget.

#### 6. PROPOSITION 64 – CITY COUNCIL STUDY SESSION

On November 8, 2016, California voters approved Proposition 64, which legalized recreational marijuana use in California and authorized the creation of state regulations

and agencies pertaining to state licensing of recreational marijuana. The purpose of this City Council study session is to provide the City Council with a summary of Proposition 64 and the authority created and limitations placed on recreational marijuana in California. Moreover, the study session also outlines the City of Bell Garden's authority and options following the passage of Proposition 64.

Recommendation: It is Staff's recommendation that the City Council:

- (1) Provide City Staff with further direction regarding Proposition 64 and related issues; and
- (2) Receive and file this presentation
