## NOTICE OF PUBLIC HEARING

### CONSIDERATION OF ADOPTION OF ORDINANCE NO. 939 AMENDING BELL GARDENS MUNICIPAL CODE (“BGMC”) CHAPTER 5.25 OF TITLE 5 “BUSINESS LICENSES, REGULATIONS AND TAXES” TO AMEND GROSS REVENUES LICENSE FEES FOR CARD CLUBS

**NOTICE IS HEREBY GIVEN**, the City Council of the City of Bell Gardens will conduct a public hearing to consider the adoption of Ordinance No. 939 to amend BGMC Chapter 5.25 “Card Club License Regulations” modifying the gross revenue license fee. Copies of the proposed changes are available for review as part of the agenda packet.

**DATE OF HEARING:** Monday, May 13, 2024

**TIME OF HEARING:** 6:00 P.M., or as soon thereafter as possible.

**ENVIRONMENTAL DETERMINATIONS:** The proposed ordinance is exempt from the California Environmental Quality Act (“CEQA”) (Pub. Res. Code § 21000 et seq.) under the common sense exemption set forth at California Code of Regulations, Title 14, § 15061(b)(3) (“CEQA Guidelines”) because it can be seen with certainty that there is no possibility that the adoption of this proposed ordinance amending card club gross revenue license fees would have a significant effect on the environment and the proposed ordinance constitutes an activity not considered a project according to section 15060(c) (3) since there is no anticipation of a direct or reasonably foreseeable indirect physical change in the environment pursuant to section 15060(c)(2).

**INVITATION TO BE HEARD/PUBLIC PARTICIPATION:** The public hearing will be held before the City of Bell Gardens City Council on Monday, May 13, 2024, at 6:00 p.m. The public may attend the meeting in person or may view the meeting online. The meeting will be recorded and live streamed on the City's website at <https://www.bellgardens.org/i-want-to/watch-city-council-meetings>. Public comments for the public hearing are limited to three (3) minutes per person. Members of the public can access and participate in the meetings as follows:

**IN-PERSON:** Members of the public can provide in-person comments at the podium in the Council Chamber. The Council Chamber will have seating available for members of the public to attend the meeting in-person, subject to capacity limits. Public comments for the public hearing are limited to three (3) minutes per speaker. Speakers who wish to address the City Council should do so by submitting a "Public Comment Card" by 6:00 p.m. for all other designated public comment periods as listed.
