3. RECEIVE AND FILE THE LOCAL COMMISSIONS APPOINTMENT LIST

The local appointments list includes the Bell Gardens Commissions and Commissioners. The City Council adopted Ordinance No. 825 on July 13, 2009 which consolidated the existing City Commissions and established minimum requirements for service. It should be noted that all Commission Members must reside within the City of Bell Gardens and may only serve on one Commission at a time. Once appointed, each Commissioner must adhere to the requirements of the City's Conflict of Interest Code and statemandated AB 1234 ethics training. Ordinance 825 allows each Council Member to nominate one (1) candidate per Commission, subject to the approval of the Council majority. The appointed Commission Member will serve a term that coincides with the term of the Council Member who made the original nomination.

Recommendation: It is staff's recommendation that the City Council receive and file the local commissions appointments list.

6. FIREWORK STAND APPLICATIONS

Pursuant to Bell Gardens Municipal Code (Code) Section 16.40, no person shall sell fireworks within the City without first having applied for and received a permit in compliance with the terms set forth in the Code. Permits are issued only to non-profit associations or corporations organized primarily for veteran, patriotic, welfare, civic betterment, or charitable purposes. Included for your review are the following 6 applications in compliance with the code provisions received by the Community Development Department: 1) La Senda Antigua; 2) La Pentecostals; 3) Mision Cristiana

"Monte De Sion"; 4) Full Gospel Assembly of God; 5) Iglesia del Nazareno Nueva Vida; 6) Bell Gardens High School Band Boosters.

Recommendation: It is recommended that the City Council approve the 6 applications from organizations seeking to operate firework stands within the City limits from June 28, 2016, 12:00 p.m., through July 5, 2016, 12:00 p.m.

DISCUSSION (Item No. 7)

7. <u>AWARD OF STREET TREE MAINTENANCE SERVICES CONTRACT TO WEST COAST ARBORISTS, INC.</u>

The City owns and is responsible for approximately 4,500 trees which comprise its urban forest including public parks, facilities, streets and median islands. The Citywide tree maintenance program consists of trimming half of these trees annually. Staff solicited Requests for Proposals ("RFPs") by sending RFPs to seven companies that specialize in tree maintenance contracts for public agencies and advertising in the Eastside Sun and on the city website. As of the bid submission deadline date of April 11, 2016, three proposals were received. After reviewing the initial contract price proposals, City Staff closely reviewed each proposal to determine if the proposals conformed to the requirements of the City's RFP. After this review, it was determined by staff that TLC's proposal should be rejected as non-responsive, because it failed to fully answer the form entitled "Contractor's Organization Statement and Performance History," sections A, D, G, H, and I. Based on the two responsive, responsible bids, WCA submitted the lowest bid at \$173,643 per year. Therefore, staff has determined that West Coast Arborists, Inc. is lowest, responsive bidder and is qualified with the experience, resources, expertise, and proven history to provide the necessary citywide tree trimming services. If approved, the contract with WCA cost the City \$173,643 annually. The 2015-2016 Fiscal Year Budget includes sufficient funds in the Public Works Maintenance and Operation budget for annual tree trimming.

Recommendation: It is recommended that the City Council:

- (1) Determine the bid submitted by Trimming Land Company, Inc. as non-responsive;
- (2) Award the annual contract for citywide tree trimming to West Coast Arborists, Inc. for a period of three (3) years, beginning on June 1, 2016, and expiring on June 1, 2019; and
- (3) Authorize the City Manager to execute an agreement with West Coast Arborists, Inc. in a form approved by the City Attorney and authorize the City Manager to administratively approve two (2) one-year extensions, if WCA has performed well during their contract period.
