## **NOTICE OF PUBLIC HEARING**

CONSIDERATION OF ORDINANCE NO. 943 AMENDING CHAPTER 9.04 (DEFINITIONS), CHAPTER 9.12 (COMMERCIAL ZONES), CHAPTER 9.14 (INDUSTRIAL ZONE), CHAPTER 9.20 (SPECIAL USES AND APPLICABLE STANDARDS), AND CHAPTER 9.38 (PARKING AND LOADING (OFF STREET)) OF TITLE 9 (ZONING AND PLANNING REGULATIONS) OF THE BELL GARDENS MUNICIPAL CODE TO REGULATE VEHICLE PARKING AND STORAGE FOR AUTOMOBILE REPAIR USES

NOTICE IS HEREBY GIVEN; the City of Bell Gardens City Council will conduct a public hearing to consider the adoption of an ordinance amending Chapter 9.04 (Definitions), Chapter 9.12 (Commercial Zones), Chapter 9.14 (Industrial Zone), Chapter 9.20 (Special Uses and Applicable Standards) and Chapter 9.38 (Parking and Loading (Off Street)) of Title 9 (Zoning and Planning Regulations) of the Bell Gardens Municipal Code to regulate off-street vehicle parking and storage for automobile repair uses. DATE OF HEARING: Monday, July 22, 2024.

**TIME OF HEARING:** 6:00 P.M., or as soon thereafter as possible.

**ENVIRONMENTAL DETERMINATIONS:** Ordinance No. 943 has been assessed in accordance with the California Environmental Quality Act ("CEQA") (Pub. Res. Code § 21000 et seq.) and CEQA Guidelines (Cal. Code Regs., tit. 14, § 15000 et seq.). The Project is categorically exempt from the requirements of CEQA pursuant to CEQA Guidelines Section 15061(b)(3) (Common Sense Exemption). The approval of this ordinance would not result in any physical improvements or developments and future projects would be subject to discretionary review and subject to CEQA and environmental review. Therefore, it can be seen with certainty that the adoption of this ordinance would not result in any direct or indirect environmental impacts.

INVITATION TO BE HEARD/PUBLIC PARTICIPATION: The public hearing will be held before the City of Bell Gardens City Council at 7100 Garfield Avenue, Bell Gardens, CA 90201 on Monday, July 22, 2024, at 6:00 p.m. The public may attend the meeting in person or may view the meeting online. The meeting will be recorded and live streamed on the City's website at <a href="https://www.bellgardens.org/i-want-to/watch-city-council-meetings">https://www.bellgardens.org/i-want-to/watch-city-council-meetings</a>. Public comments for the public hearing are limited to three (3) minutes per person. Members of the public can access and participate in the meetings as follows:

**IN-PERSON:** Members of the public can provide in-person comments at the podium in the Council Chamber. The Council Chamber will have seating available for members of the public to attend the meeting in-person, subject to capacity limits. Public comments are limited to three (3) minutes for each designated public comment period(s) per speaker unless a different time is announced by the presiding chair. Speakers who wish to address the City Council should do so by submitting a "Public Comment Card" card by 6:00 p.m. for all other designated public comment periods as listed.
