PUBLIC HEARING (Items No. 1-2)

1. ZONING CODE AMENDMENT NO. 2016-030; ORDINANCE NO. 874 (FILE NO. 2016-030) – LANDSCAPING

Approval of Zoning Code Amendment No. 2016-030 and the adoption of Ordinance No. 874 to amend Chapter 9.34, "Landscaping," in its entirety will allow the City to be in compliance with all applicable State Laws. Ordinance No. 874 will establish new regulations for landscaped areas in all zones, parkway landscaping, the use of artificial turf, and the use of drought tolerant and water efficient landscape materials, and water efficient irrigation systems.

Recommendation: It is the recommendation of the Planning Commission that the City Council approve Zoning Code Amendment No. 2016-030 and introduce and waive first reading of Ordinance No. 874 amending and replacing in its entirety the Bell Gardens Municipal Code Title 9 Zoning and Planning Regulations Chapter 9.34, "Landscaping," establishing new regulations for landscaped areas in all zones, parkway landscaping, the use of artificial turf, and the use of drought tolerant and water efficient landscape materials and water efficient irrigation systems.

2. ZONING CODE AMENDMENT NO. 2016-039; ORDINANCE NO. 879 (FILE NO. 2016-039) - MASSAGE ESTABLISHMENTS

In response to the directive provided to staff with the adoption of Emergency Ordinance No. 861-U, staff is proposing Zoning Code Amendment No. 2016-039 to change the land use regulations governing massage establishments contained in the Zoning Code. Ordinance No. 879 proposes that massage establishments be permitted in the C4 zone subject only to the requirements of Bell Gardens Municipal Code Chapter 5.46 (as amended), and that the current requirement for a conditional use permit and the special development regulations contained in Zoning Code Section 9.20.115 be eliminated. The conditional use permit and the development regulations contained in the Zoning Code

would no longer be necessary, as they would now be addressed within the new Municipal Code Chapter 5.46 (as amended). Approval of Zoning Code Amendment No. 2016-039 and adoption of Ordinance No. 879 would change "massage establishment" from a conditionally permitted use to a permitted use in the Heavy Commercial(C-4) zone, subject to the provisions contained in the Bell Gardens Municipal Code Chapter 5.46 (as amended), and will eliminate Section 9.20.115, "Massage Businesses-Conditional Use."

Recommendation: It is the recommendation of the Planning Commission that the City Council take the following action:

- 1. Approve Zoning Code Amendment No. 2016-039 and introduce and conduct first reading of Ordinance No. 879 amending the Bell Gardens Municipal Code Title 9 Zoning and Planning Regulations as follows:
 - a) Chapter 9.12, "Commercial Zones," Section 9.12.030 "Permitted Uses, Table 9.12.A: Commercial Land Use Matrix," to change "massage establishment" from a conditionally permitted use to a permitted use in the Heavy Commercial (C-4) zone, subject to the provisions contained in the Bell Gardens Municipal Code Chapter 5.46; and
 - b) Chapter 9.20, "Special Uses and Applicable Standards," eliminating Section 9.20.115, "Massage Businesses-Conditional Conditional Use."

5. RECEIVE AND FILE THE LOCAL COMMISSIONS APPOINTMENT LIST

The local appointments list includes the Bell Gardens Commissions and Commissioners. The City Council adopted Ordinance No. 825 on July 13, 2009 which consolidated the existing City Commissions and established minimum requirements for service. It should be noted that all Commission Members must reside within the City of Bell Gardens and may only serve on one Commission at a time. Once appointed, each Commissioner must adhere to the requirements of the City's Conflict of Interest Code and state-

mandated AB 1234 ethics training. Ordinance 825 allows each Council Member to nominate one (1) candidate per Commission, subject to the approval of the Council majority. The appointed Commission Member will serve a term that coincides with the term of the Council Member who made the original nomination.

Recommendation: It is staff's recommendation that the City Council receive and file the local commissions appointments list.

7. REJECTION OF CLAIMS

The City directed the original claim to Carl Warren & Company. Following an investigation by the City's claims management administrator, the claim is being presented for rejection.

Recommendation: It is staff's recommendation that the City Council reject the claim filed by Jose Daniel Hernandez Adame. The claim is being presented for rejection following a recommendation by the City's claims management administrator, Carl Warren & Company, and in a manner that allows the claimant, subject to certain exceptions, up to six months to file a court action on the claim.

8. <u>ADOPTION OF ORDINANCE NO. 875 MASSAGE ESTABLISHMENTS (FILE NO. 2016-071)</u>

On August 8, 2016, the City Council introduced Ordinance No. 875 and waived first reading of the ordinance. On October 27, 2014, the City of Bell Gardens City Council adopted Urgency Ordinance No. 861-U, an Interim Urgency Ordinance, declaring and imposing a citywide moratorium on the establishment, expansion, or relocation of massage therapy establishments for 45 days. The City subsequently extended the moratorium two consecutive times to allow staff sufficient time to formulate a comprehensive "massage ordinance." In response to the directive provided to staff with the adoption of Emergency Ordinance No. 861-U, staff is proposing Ordinance No. 875 which would establish new regulations governing massage establishments in the City.

Recommendation: It is staff's recommendation that the City Council waive second

Recommendation: It is staff's recommendation that the City Council waive second reading and adopt Ordinance No. 875, repealing Urgency Ordinance No. 871-U, repealing Bell Gardens Municipal Code Chapter 5.46 "Physical Therapy Massage" in its entirety and adopting a new Chapter 5.46 "Massage Establishments," to establish comprehensive regulations governing massage establishments.

Any writings or documents provided to the majority of the City Council/Successor Agency regarding any item on this agenda will be made available for public inspection at the Receptionist Counter, City Hall, 7100 Garfield Avenue, Bell Gardens, CA, during normal business hours.

9. PARTICIPATION IN THE STATE OF CALIFORNIA BOARD OF STATE AND COMMUNITY CORRECTIONS PROGRAM

The Bell Gardens Police Department operates a Type I jail facility, which is defined as a local detention facility used for the detention of persons for not more than 96 hours excluding holidays after booking. The State of California Board of State and Community Corrections Program provides funding to law enforcement agencies for the training of all newly hired employees, supervisors, and/or managers of Type I detention facilities. The State of California Corrections Standards Authority has certified our jail as a Type I detention facility, qualifying the City to receive these funds, which are designated strictly for training of personnel who are employed to perform duties in the jail. City Council approval as a program participant is required prior to issuance of these funds. Based on our population, it is estimated that the City of Bell Gardens will receive \$11,440.

Recommendation: It is staff's recommendation that the City Council adopt Resolution No. 2016-31 entitled, "A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF BELL GARDENS APPROVING PARTICIPATION IN THE STATE OF CALIFORNIA BOARD OF STATE AND COMMUNITY CORRECTIONS PROGRAM AND ACCEPTING FUNDS FOR USE TOWARD THE POLICE DEPARTMENT'S JAIL MANAGEMENT TRAINING PROGRAM."

10. <u>APPROVAL OF PROFESSIONAL SERVICES AGREEMENT AND PAYMENT OF INVOICE FOR B.A. INVESTIGATIONS</u>

On June 14, 2016, the City Manager entered into a Professional Services Agreement with B.A. Investigations to conduct a confidential administrative investigation for the police department. On August 8, 2016, the confidential investigation was concluded and the Chief of Police received a detailed report with the investigator's findings. Given the unanticipated amount of information collected and length of time needed to conclude a thorough investigation, costs exceeded the City Manager's approval authority of \$10,000. Therefore, this item is being presented to City Council for the purpose of approving the Professional Services Agreement with B.A. Investigations and authorizing payment of the invoice submitted by the investigator. Funds are maintained in the police department's FY2016-17 Operating Budget under contract services for this purpose. The total cost of the investigation to include transcripts is \$11,430.

Recommendation: It is staff's recommendation that the City Council adopt Resolution No. 2016-32 entitled, "A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF BELL GARDENS APPROVING A PROFESSIONAL SERVICES AGREEMENT WITH B.A. INVESTIGATIONS AND AUTHORIZING PAYMENT OF FINAL INVOICE."
