Pursuant to the Bell Gardens Municipal Code (BGMC) Section 5.63.090, an annual fee for the registration of residential rental units in the amount of **\$156.00 per unit** has been established to recover the reasonable costs associated with the administration and enforcement of Ordinance No. 925, or the Bell Gardens Rent Stabilization and Tenant Eviction Protections Program (RSTEP).

Property owners paying the registration fee after a 30 day grace period, shall pay, in addition to the registration fee, late charges as follows: Ten percent (10%), if paid between 31 days and 60 days past the due date; Twenty-five percent (25%), if paid between 61 days and 90 days past the due date; and Fifty percent (50%), if paid after 90 days past the due date.

Please note that all information must be up-to-date. The City of Bell Gardens Community Development Department's Housing Division will contact you should any information be incomplete or incorrect.
