PUBLIC HEARING (Item Nos. 1 - 2)

1. INTRODUCTION OF ORDINANCE NO. 948 TO AUTHORIZE A DEVELOPMENT AGREEMENT BY AND BETWEEN THE CITY OF BELL GARDENS, BG FLOWER, LLC AND 7601 EASTERN, LLC RELATING TO THE PROPERTY LOCATED AT 7601 EASTERN AVENUE IN THE CITY OF BELL GARDENS

Waive full reading and introduce Ordinance No. 948, by title only, approving the proposed Development Agreement No. 2024-054 for a cannabis retail storefront at 7601 Eastern Avenue.

Recommendation:

It is staff's recommendation that the City Council waive full reading and introduce Ordinance No. 948, by title only, approving the proposed Development Agreement No. 2024-054 for a cannabis retail storefront at 7601 Eastern Avenue.

2. CONSIDERATION OF ORDINANCE NO. 949 ADOPTING A MILITARY EQUIPMENT USE

POLICY AS REQUIRED BY ASSEMBLY BILL 481

The proposed Ordinance No. 949 adopts a policy for Bell Gardens Police Department ("Department") in compliance with Assembly Bill 481 (Chiu) ("AB 481") to address the funding, acquisition, and use by the Department of items deemed "military equipment" by lawmakers. The policy meets the law's requirements by listing the Department's inventory of military equipment; outlining a process for the public to submit questions, concerns, and complaints in relation to the use of each type of equipment; providing for the preparation of an annual report subject to City Council review and approval; and establishing a webpage for updates and the posting of annual reports.

Recommendation:

It is staff's recommendation that the City Council waive the full reading and introduce Ordinance No. 949 by title only, adopting a Military Equipment Use Policy in accordance with state law.

PUBLIC COMMENTS ON NON-AGENDA ITEMS UNDER THE SUBJECT MATTER JURISDICTION OF THE CITY COUNCIL / SUCCESSOR AGENCY

During this time, the members of the public may address the City Council / Successor Agency regarding any items within the subject matter jurisdiction of the City Council / Successor Agency. 10. <u>CONSIDERATION OF RESOLUTION APPROVING GRANT AGREEMENT NO. 17869</u> <u>WITH THE DEPARTMENT OF CALIFORNIA HIGHWAY PATROL</u>

The Bell Gardens Police Department applied for and was awarded the FY24/25 CTFGP Law Enforcement – Bell Gardens Police Department Grant in the amount of \$101,498.70. The grant requires that the City Council formally accept these funds by executing Grant Agreement No. 17869.

Recommendation:

It is staff recommendation that the City Council adopt the attached Resolution approving Grant Agreement No. 17869 with the Department of California Highway Patrol, thereby accepting grant funds.

14. <u>CONSIDERATION OF FRANCHISE AGREEMENT FOR POLICE ORDERED TOWING</u> <u>AND STORAGE SERVICES</u>

On June 4, 2024, a notice for a Request for Proposal for a Non-Exclusive Franchise Agreement for Towing and Storage services was released. Three (3) proposals were received.

Police Department Staff evaluated each proposal and provided a grading based on certain criteria spelled out in the Request for Proposals. In addition to reviewing each of the submitted proposals, Staff from the Police Department conducted on-site visits, which allowed Staff to confirm that the proposers adhered to requirements listed in the Request for Proposals and that the information listed in their respective proposals was true and correct.

Recommendation:

It is staff recommendation that the City Council adopt the attached Resolution authorizing the City Manager to execute a Non-Exclusive Franchise Agreement for vehicle towing and storage services with the selected Vendor, subject to approval by City Attorney.

15. AQUATICS CENTER PROJECT UPDATE - AUGUST 2024
